Test Bookings – Terms & Conditions

I understand that :

- it is my responsibility to ensure that I have the necessary documentation with me on the day of my test (*photocard driving licence*)
- it is my responsibility to ensure that my eyesight is compliant with test requirements either with or without corrective glasses (see "Gov.uk")
- the test fee paid to you is in respect of the fee due to the DVSA to cover the examiner's time and does NOT include the hire of your training vehicle on the day of my test which will be subject to an additional charge
- if I am proposing to use your training vehicle the test will be booked by you to ensure that there is no conflict with other driving tests or lessons already pre-booked
- the booking of my test by you does NOT imply that my standard of driving is currently at the required level to pass a driving test OR that it will be reached by the appointed test date
- you reserve the right to withhold the use of your training vehicle for my test if in your opinion I am a) not at driving test standard, b) medically unfit, c) under the influence of drugs or alcohol, d) not properly licenced to drive, e) consistently cancelling appointments, f) falling into arrears over payment of your fees, and g) unsafe to handle a motor vehicle

I agree :

- to indemnify you for any uninsured losses (*typically insurance excess*) incurred by you as a result of my actions whilst driving your training vehicle on test
- to settle any outstanding fees by cleared means prior to taking my test
- that you cannot be held responsible for any test postponement or cancellation by the testing authority or where the test cannot take place due to factors beyond your control
- to notify you at the earliest opportunity of any test date or time amendments received by telephone or in writing directly from the testing authority
